The wheels need replaced and the cost to split will be around \$8,900.00, including shipping both ways to S. Dakota. This will be on the September agenda.

Toby Brewer discussed the desire of several residents to be allowed to have chickens and also shared the published medical benefits of owning and interacting with them.

Sewers Chairman Ellis said he looked at sidewalks and drain stations with Jason Biava. Gas & Water Chairman McFadden said they conducted nine interviews and had several quality applicants. Sidewalks Chairman Ellis said he needs to create a 'needs list' and prioritize for sidewalk repair. Park Chairman Gallion reported that the sidewalk work in the park is completed, as well as the fence work. He said there is a mole issue that they will address. The damaged light pole from the June storm has been removed and the new one will be delivered on Friday and should be put up by RC Electric next week. Bldgs./Grnds.-Comm. Beaut. Chairwoman Hughes Snyder got the demolition bid and demo should be done early this fall for Victor and Kelly properties. The planters at the square are painted and flowers planted; city hall was also painted.
